**ON SOME ADDITIONS AND CHANGES IN THE INTERNAL REGULATION
OF THE SCHOOL OF MAGISTRATES**

Based on law no. 96/2016, *on the status of judges and prosecutor in the Republic of Albania*, of law no. 115/2016, *on the organs of the management of the system of justice*, the Steering Council of the School of Magistrates, gathered on 30.11.2023, decided:

I. To be done these additions and changed in the Internal Regulation of the School of Magistrates approved by decision no. 1, date 31.1.2017, amended:

1. In Article 66/3 “Department of scientific research and publications,” is added letter “i” with this content:

“i) to encourage and promote the creation of spaces of discussion between magistrates and practitioners of law through the Forum of the School of Magistrates.”

2. After Annex 15 is added Annex 15/2, “On the activity of the Forum of the School of Magistrates,” attached to this decision.

3. Annex 10 and Annex 10/2, change according to the content attached to this decision.

**ON SOME ADDITIONS AND CHANGES IN DECISION NO. 25, DATE
23.10.2017, ON THE REMUNERATION AND REGULATION OF THE
ACADEMIC ACTIVITY, IN THE APPLICATION OF THE PROGRAM
OF INITIAL AND CONTINUOUS FORMATION IN THE SCHOOL OF
MAGISTRATES**

Based on Article 118 of the Constitution of the Republic of Albania, on Articles 243 and 248 of law no. 115/2016, *on the organs of the management of the system of justice*, law no. 96/2016, *on the status of judges and prosecutor in the Republic of Albania*, no. 98/2016, *on the organization of the judicial power in the Republic of Albania*, no. 84/2016, *on the transitory re-evaluation of judges and prosecutors in the Republic of Albania*, on Article 124 of law no.

80/2015, *on the high education in the Republic of Albania*, (amended), as well as of law no. 84/2022, *on the budget of the year 2023*, on the decision of the Council of Ministers no. 748, date 11.6.2009, *on the treatment with salary and salary allowances of the academic personnel of public institutions of high education*, (amended), with the proposal of the Director of the School of Magistrates, the Steering Council of the School of Magistrates, gathered on 30.11.2023, decided:

1. Point 10, changes as follows:

2. Normed annual lecturing for the full – time academic personnel, expressed in converted classes in the Initial Formation is as follows:

- For the Director the School up to 70 classes in auditorium/175 converted classes
- For the Heads of Programs (Initial and Continuous) 140 classes in auditorium /350 converted classes
- For full – time lecturers 160 classes in auditorium /400 converted classes

b) In point 11/a, after the phrase “20% of classes” is added the phrase “over the norm.”

2. Financial effects are extended for the Academic year 2023 – 2024.

3. This decision comes immediately into force!
